Notes

Fueling: All fuel must be stowed inside the trailer or in the back of the truck. Absolutely NO fuel will be allowed on the ground. All teams must have a tarp under the race boat trailer for fueling and absorbent material to be placed at the neck of the fuel fill. A 10 lb fire extinguisher must be present at all times when fueling.

Parking in the Pits: Only race teams will be allowed to park in the pits on Friday/Saturday per the Blue Water Resort Mgmt. All other non essential vehicles must park in the resort parking lot above. Race teams must have credentials to get in and out of pits both Friday & Saturday.

Legal Division IV Grand Nationals that are SCSC members are eligible for double points.

Note: Sunday, October 25th is a blowout day in case of weather, incident or anything that precludes the finish of the event on Saturday, October 24th.
